

## INSTRUCTIONS TO FOLLOW AFTER YOU CLICK THE START BUTTON

Step 1. You must create an account FIRST

The Start button will take you to the Request Tracker Login screen. Step 1 and 2 of these instructions are creating an <u>account</u> (this is not the e-mail registration). AFTER you create your account you will be directed to the e-mail registration screen. The <u>account</u> (step 1 and 2) can be any e-mail address in your office that you designate to control the registration process - it does not have to be the attorney.



Note: After the account is created, the next time you need to register an attorney e-mail or register an update to an attorney email previously submitted to the Lucas County Common Pleas Court you can use the Login button instead of the New User button which will skip you to step 3.
