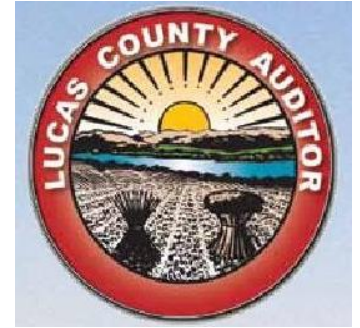




**Current Agricultural Use Valuation (CAUV)
