IMPORTANT INFORMATION ABOUT YOUR OHIO VOTER REGISTRATION

- If you have moved and have not updated your address as described above by 10/9/2018 (the voter registration deadline for the 11/6/2018 General election), you may be required to cast a provisional ballot when you appear on Election Day at your current voting location.
- If you do not **UPDATE** or **CONFIRM** your address as described above and do not vote in Ohio by the 2022 General Election (the second regular general election for federal office that occurs after the issue date on this notice), your voter registration in Ohio will be cancelled pursuant to federal law and **YOUR NAME WILL BE REMOVED FROM THE VOTER REGISTRATION LIST.**
- If you have permanently moved to another state and you complete the second box above with the address in your new state, you are confirming that you no longer are eligible to be registered to vote in Ohio and your voter registration in Ohio will be cancelled.
