CONSTRUCTION DEPARTMENT

- ✓ **General Permit** – This permit is for any work being done within the public road right-of-way on all County or Township Roads where other permits do not apply. (i.e. pavement cuts, utility connections, mailbox installation, tree or landscape planting, placement of additional driveway stone, etc.)

STORMWATER DEPARTMENT

- ✓ **Storm Water Pollution Prevention Plan (SWPPP)** – This plan and permit is required for any construction activities that will disturb more than one (1) acre of ground within any of the unincorporated areas of Lucas County. Construction activities include: any clearing, grading, excavating, grubbing and/or filling.
- ✓ **Permission to Enclose** – This permit is for permission to enclose a ditch or swale with a storm sewer, culvert, or bridge for drive access. (You must have an access permit first before this permit can be issued).
- ✓ **Permission to Connect Permit** – This permit is for permission to connect or tap into an existing public storm drain (catch basin, enclosed pipe, or open ditch) on County or Township roads.
- ✓ **Permission to Curb Cut Permit** – This permit is for permission to modify the existing curb for a proposed driveway on County or Township roads.
- ✓ **Floodplain Hazard Development Permit** – This permit is for permission to develop in the regulated FEMA Special Flood Hazard Area (i.e. 100 Year Floodplain)
- ✓ **Grading and Drainage Permit**– This permit is for permission to begin any earth moving activity on Township parcels outside of platted subdivisions.

TRAFFIC AND PLANNING DEPARTMENTS

- ✓ **Access Permit** – This permit is **required for all lot splits** (excluding those in a city or village) within Lucas County. Additionally, this permit is **required for the construction of all new driveways, for modifications of existing driveways, and for any a “change in use” of an existing driveway** that provides access to County or Township roads.

BRIDGE DEPARTMENT

- ✓ **Special Hauling Permit** – This permit is for permission for special hauling of loads over state legal loads or size limits on County or Township roads.
