

JOINT COUNTY DITCH PETITION

Revised Code § 6131.04; § 6133.02 and §6133.03

TO THE JOINT BOARD OF COUNTY COMMISSIONERS, FULTON AND LUCAS COUNTIES, OHIO:

The undersigned hereby petition your honorable body to for an improvement in a manner deemed to be most conducive to the public welfare of the primary watercourses within the Ten Mile Creek Watershed utilizing any, all, or a combination of methods provided in Ohio Revised Code Section 6131.01 (C) (1) (2) (3) (4) (5) necessary for the disposal of surplus water.

The construction of the improvement is necessary, will benefit the petitioner (s) and will be conducive to the public welfare. All costs of engineering, construction, and maintenance will be assessed to the benefiting parcels of land, except as ordered under Section 6131.31 of the Ohio Revised Code.

The following is the list of watercourses included in the proposed improvement. The watercourses are further detailed by the county that includes either the entirety or a segment of the watercourse. These watercourses were selected on the basis of servicing a draining area greater than two square miles, the presence of floodplain area in a watercourse's drainage area, or upon the County Engineer's discretion. The course and termini of each watercourse is illustrated in the attached series of maps.
